• Limit of 1 large piece (max. 16" x 16") and/or 4 small pieces (i.e. jewelry, ornaments, cards (multiples of 4 different images), small pottery, etc.

- All artwork must be for sale and there must be a replacement piece for each item that sells. Price must be indicated on the entry form.
- All artwork must be gallery ready for hanging and presentation.
- The SSAC will receive a 30% donation on all sales.
- Artists will be paid for sold work within 30 days of the close of show.
- Bin work must be shrink wrapped with the label tag, maximum cost is \$200
