The Steamboat Springs Arts Council and our generous volunteer team will select the exhibitors. Preference will be given on a first come, first served basis.

TERMS AND CONDITIONS

Exhibitors must agree to the following conditions upon application.

All display tables, chairs, and additional materials needed for booth set-up must be provided by the exhibitor. Booth sizes and locations will be allocated in order of exhibitor selection, as mentioned above. Exhibitors must display original art and craft; no bulk and/or outsourced products. Exhibitors sell and exhibit at their own risk. The Arts Council is not responsible for damage or theft of any work or personal property. Booths must remain set-up through the duration of the show. Electricity is limited and only available to vendors who absolutely need it and request it in advance.

Booth fees are non-refundable after the November 5th deadline. If you are not able to fulfill your commitment to exhibit, please contact the Arts Council.

Exhibitors are responsible for cleaning their space at the end of the show between 3:00 – 4:30pm, Saturday, December 1, 2018. Failure to cleanup may result in non-acceptance at future shows.

IMPORTANT TAX INFORMATION

Exhibitors will be required to have Colorado tax numbers and collect State and County Tax. County Tax is 1% or .01. State Tax is 2.9 % or .029. Strawberry Park is not within the city limits so city tax is not charged for this event.
