- This show will require the participation of all artists to help produce the exhibit. There will be opportunities to help with set up and hanging, poster distribution, reception and gallery sitting. All artists are asked to help with publicity and refreshments for Friday’s Reception on December 3rd.

SALE OF ARTWORK:

- Limit of 1 large piece (max. 16”X16”) and/or 4 small pieces (i.e. jewelry, ornaments, cards (multiples of 4 different images), small pottery, etc.
- All artwork must be for sale and there must be a replacement piece for each item that sells. Price must be indicated on the entry form.
- All artwork must be gallery ready for hanging and presentation.
- Steamboat Creates will receive a 30% donation on all sales.
- Artists will be paid for sold work within 30 days of the close of show.
- Bin work must be shrink wrapped with the label tag, maximum cost \$200
